



REGULATION FOR THE GRANT OF UNGUARDED AREA GENERAL CONTRACT CONDITIONS PURSUANT TO ART. 1341 Civil Code

The service is provided to the public pursuant to art. 1336 civil code under the following conditions:

DEFINITIONS

For the purposes of this Regulation for the concession of use of unguarded areas, the following expressions, both singular and plural, will have the meaning indicated below:

- a) "Supplier": SDAG S.p.a. a socio unico, company concessionaire of the parking areas of the Autoporto di Gorizia and Stazione Confinaria di S.Andrea, Gorizia;
- b) "User": The customer who directly uses the service provided by the Supplier.

ART. 1. Parking is allowed in designated areas according to the regulations provided by the following general contract conditions pursuant to articles 1336 and 1341 civil code.

Upon introduction of the vehicle and collection of the entry ticket (bearing the day and time of issue), a contract is activated between the User and the Supplier on the concession of an unguarded area, without obligation of supervision and custody. The Supplier is therefore not responsible for damage or theft committed or attempted to the vehicles or their accessories, or to luggage, valuables and other objects left inside the vehicle.

ART. 2. Entry into the car park takes place from the access gate which leads to the parking areas delimited by barriers, according to any of the following methods: a) Collecting the entry ticket from the column positioned there; b) Using the card-in system; c) Reading of the license plate (if the User has previously entered into a contract with the Supplier).

The User is the sole responsible for the custody or loss of the entry ticket, in accordance with the provisions of art. 8. Entry involves authorization to park according to the rates displayed at the access gate to the individual parking areas. The User is recommended not to leave the ticket exposed to light and/or heat sources.

ART. 3. Users have the duty to:

- Scrupulously respect road signs and the rules of the Highway Code;
- Follow the direction of traffic indicated by the signs and keep their speed no higher than walking pace;
- Leave the vehicle parked with engine off and perfectly braked;

- Keep the ticket until collecting the vehicle and exiting the parking area.

If damage to third parties arises from failure to fulfill these duties, the User will be held responsible for such damage.

ART. 4. Users are prohibited from:

- Stop unnecessarily with the engine running;
- Obstruct traffic by parking along the traffic lanes or in any other space outside the parking areas delimited by barriers;
- Carry out any fuel transfer;
- Spill oil or other material that could dirty and/or damage the floor or drains; in the event of damage to the flooring, the restoration costs will be charged to the User;
- Leave the vehicle parked for more than 15 days, unless previously communicated to and authorized by the Supplier;
- Unhitch and/or park trailers;
- Access the parking area with cars unless authorized by the Supplier.

ART. 5. Payment must be made either at the appropriate cash desks before collecting the vehicle or by previous direct agreement with the Supplier. In the event of unavailability of the automatic cash registers or if required by the Supplier's staff, payment can be made at the manned cash register.

Payment at the automatic pay stations can be made in cash, credit card or debit card.

ART. 6. The exit of the vehicle must take place within 15 minutes from payment time. Once the tolerance times indicated above have elapsed, the User will be required to restart the payment procedure and proceed to a new payment according to the tariff applied starting from the expiration of the previous one.

ART. 7. Failure to pay authorizes the Supplier not to allow the exit of the vehicle. The User who shows up at the cash desk without the entry coupon is required to provide the documents certifying the actual ownership of the vehicle and all the document useful to demonstrate the duration of the parking. The User will be required to pay the sum corresponding to a continuous stay of 7 days even in the case of partial failure to produce the documents.
