

PRIVACY POLICY FOR USER SERVICES

Pursuant to Article 13 of Regulation 679/2016 (GDPR) on the protection of personal data, we take care to provide you with some information relating to the processing of your personal data in the context of the professional, contractual and economic relationship with our Entity. The Data Controller is SDAG spa a socio unico (Registered office: Stazione Confinaria S. Andrea, 34170 Gorizia), the contact details of the Data Protection Officer (DPO) are easily available on the Data Controller's website (www.sdag.it).

We will process your data for purposes connected and instrumental to the provision of marketing services.

- Concession of Warehouse, Office and Parking spaces. In particular, this activity involves the processing and storage of contact data, including the mobile phone number for retrieval in case of urgency.
- Storage Services. In particular, this activity involves the processing and storage of contact data.
- For the publication of documents and information in the Transparent Administration section (Legislative Decree 33/13) and other publications on the website required by laws and regulations; L 190/12 obligations management activities, management of access requests, civic access, generalized access to documents.
- To manage the archiving and retention of data, information, communications including documents relating to the proceedings;
- For the protection of the Company's assets, also in relation to the video surveillance system (this constitutes information on the legitimate interest of the Data Controller pursuant to Article 13, paragraph 1, letter d) GDPR.

These activities are carried out in accordance with Article 6 paragraph 1 of the GDPR, - lett.a (Consent to processing) - lit. b (Fulfilment of a contract) - letter c (Processing necessary for compliance with a legal obligation to which the data controller is subject).

PROVISION OF DATA

The data requested will be those strictly necessary for the progress of the practice. The communication of personal data is mandatory in order to carry out the pre-contractual phases and the signing and/or execution of the contract; Therefore, the refusal or failure to provide, in whole or in part, the requested personal data may make it impossible for the Data Controller to carry out the above-mentioned steps.

RECIPIENTS OF PERSONAL DATA

The personal data collected may be disclosed to third parties when this is necessary for the Company's institutional activities, purposes and legal obligations, for example:

- Security service, for immediate contact in case of emergency
- Consultants, professionals for the purpose of controlling fiscal, accounting and administrative aspects;
- Law firms, arbitrators, insurance companies, experts, brokers for judicial, extrajudicial and insurance activities in the event of disputes and/or claims;
- -Supervisory bodies for statutory and tax auditing activities;
- Individuals, on request, for the management of requests for civic access and generalized access to documents;
- Public authorities for the management of Legislative Decree 33/2013 and Legislative Decree 50/2016;
- Judicial authorities and/or law enforcement agencies to carry out investigations, including preliminary ones

The data will be processed, in addition to manual methods, also through IT and telematic infrastructures with logics strictly related to the purposes; therefore, IT companies may be involved in the processing as suppliers of infrastructures, software and various services (e.g. maintenance services, hosting services, digital replacement storage services, SaaS cloud services).

TRANSFER OF DATA OUTSIDE THE EUROPEAN UNION

Your personal data will not be disclosed in any way to bodies or organizations in non-EU countries, except in any cases provided for by law. Any IT services used in data processing and based on cloud infrastructure ensure consistency with the provisions of Regulation 679/2016.

DATA RETENTION TIMES

The duration of the processing will be limited to the time necessary to execute the contract; The data will be stored for the duration provided for by law and to provide proof of exact fulfilment until the expiry of the limitation periods of the mandatory rights arising from the contractual terms.

RIGHTS OF THE DATA SUBJECT
